We really hope to resume meetings in January of 2021. Until them please stay well and stay safe, keep paintings and sharing your work!



WFWS About WFWS

The Western Federation of Watercolor Societies (WFWS) was formed in 1976 by the New Mexico Watercolor Society and included nine other watercolor societies. The purpose was to make a large and prestigious watercolor exhibition available at low cost to members for small and often isolated watercolor groups.

Today, the WFWS includes over 5,000 artists in eleven regional watercolor societies and guilds. The WFWS encourages and recognizes artistic excellence and works to increase visibility of watercolor as an artistic medium through our annual juried exhibitions. The exhibitions are sponsored by WFWS and hosted by a regional member society. Delegates meet annually (usually at the current show) to conduct general business and discuss the next year's plans. Each society hosts the show on a rotating basis.

Online entry only; deadline: January 10, 2021

\$35 for one entry; \$40 for two entries; \$45 for three entries

Minimum painting size: 100 square inches

Images: .jpg only, 300dpi, Under 4mb, Max of 4600px on longest side

Work must be for sale. (30% commission deducted from each sale)

Clarification on Size

Before your members enter, they should consider whether the size of their painting will qualify. If it is too small, less 100 square inches, it will not. If it is too large, larger than a full sheet, it may not. With a mat, it must not measure more than 30" x 38" on the longest side. If members think their paintings qualify, then they should proceed to ArtCall to enter their submissions.

For ArtCall submissions, only the painting size should be entered. Do not add the mat measurement.
